



INTRODUCTION

Shree Somnath Temple is the first among the twelve Jyotirlinga Shrines of Shiva. Shree Somnath Trust is managing various religious temples, Guest houses and other Pilgrim places at Somnath.

Shree Somnath Trust is receiving government grants under “PRASHAD” scheme from Government of India and other grants from State Government and also through their own resources for construction of various pilgrims related buildings, amenities and infrastructure projects.

Now in coming few years Shree Somnath Trust is looking for construction of Pilgrim Plaza, Triveni Ghat Development, New Guest House, Staff Quarters, Commercial Complex and other Construction Projects. Thus, Trustee Secretary on behalf of Shree Somnath Trust (referred to as Employer in these documents) invites Expression of Interest hereafter (EOI) for the construction of various buildings and infrastructure projects at Somnath, Prabhas Patan from reputed companies for carrying out comprehensive services.

GENERAL INSTRUCTIONS

1. The company must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts. Sub-agency's experience and resources shall not be taken into account in determining the company's compliance with the qualifying criteria.
2. Even though the company meet the qualifying criteria, they are subject to be disqualified if they have:
 - made misleading or false representations in the forms, statements and attachments submitted in proof of the qualification requirements; and/or
 - Record of poor performance such as abandoning the works, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures etc.; and/or
 - participated in the previous bidding for the same work and had quoted unreasonably high bid prices and could not furnish rational justification to the employer.
3. Each company shall submit only one bid for one contract. A company who submits or participates in more than one Bid (other than as a subagency or in cases of alternatives that have been permitted or requested) will cause all the proposals with the Company's participation to be disqualified.
4. The company shall bear all costs associated with the preparation and submission of his EOI, and the Employer will in no case be responsible and liable for those costs.



5. The Company, at the Company's own responsibility and risk is encouraged to visit and examine the Site of Works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for construction of the Works. The costs of visiting the Site shall be at the Company's own expense.
6. The company or his official representative will be invited for a meeting to discuss information provided in Expression of Interest. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.
7. EOI shall remain valid for a period not less than sixty (60) days after the deadline date for bid submission
8. The Company shall send seal envelopes, duly marking the envelopes as "EXPRESSION OF INTEREST" and should be submitted at : Yatri Suvidha Kendra, Shree Somnath Trust, Prabhas Patan, Somnath, Gujarat, India. by Dt. 15/01/2022 up to 5.00 pm
9. The agency also have to submit soft copy of documents on tenders@somnath.org by 15/01/2022.
10. Information relating to the examination, clarification, evaluation, and comparison of EOI and recommendations for the award of a prospective work shall not be disclosed to Company or any other persons not officially concerned with such process until the award to the successful Company has been announced. Any effort by a Company to influence the Employer's processing of Bids or award decisions may result in the rejection of his Bid.

11. Information required from the Company

- a) Copies of original documents defining the constitution or legal status, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Company;
- b) Experience in works of a similar nature and size for the last three years, and details of works under way or contractually committed; and clients who may be contacted for further information on those contracts.
- c) Reports on the financial standing of the Company, such as profit and loss statements and auditor's reports with Balance sheet for the past three years;
- d) Evidence of adequacy of working capital for this contract (access to line (s) of credit and availability of other financial resources);
- e) List for major construction equipment available with company
- f) Qualifications and experience of key site management and technical personnel proposed for the Contract;



- g) Quality Assurance System adopted for Each project
- h) Safety Assurance Procedure is adopted for each project
- i) Provide case study showing “Good Construction Management Practices” done by company covering quality control & assurance, Safety procedure, PERT monitoring, Manpower Training, Material Management, ISO procedure at site.
- j) Must have experience in multi-tasking approach to execute comprehensive services for the project.
- k) Shree Somnath Trust ask confidential good credential report from list of completed / ongoing projects submitted by agency. For this agency should not have any objection.
- l) CA certified bid capacity certificate as on date of submission.

12. A technical committee will do evaluation of Expression of Interest on the basis of classification of following criteria;

- a. Bid Capacity
- b. Experience of execution of comprehensive projects.
- c. Similar size & nature
- d. Good credential report from client
- e. Based on presentation and photographs
- f. Site visit by technical experts for ongoing / completed projects
- g. On the basis of meeting / opinion of end users / clients and their representatives.
